Corporate Information

Name of Company: St. Vincent and the Grenadines Port Authority

The St. Vincent and the Grenadines Port Authority (SVGPA) is responsible for the operation and administration of the Kingstown Deep Water Harbour, the nearby Campden Park Container Port (CPCP) and the Kingstown Cruise and Ferry Terminals.

Port Kingstown first began operations in September 1964 and is located in the capital city, Kingstown. The main quay is 900ft with additional 121ft of catwalk with a water dept alongside of 30ft. The Port handles both containerized and general cargo. The port also facilitates inter-island ferries and cruise ship services.

Campden Park Container Port is located just outside capital Kingstown, constructed in March 1993 at the Campden Park Industrial Estate. The Port is operated by the St. Vincent and the Grenadines Port Authority to specifically handle containers.

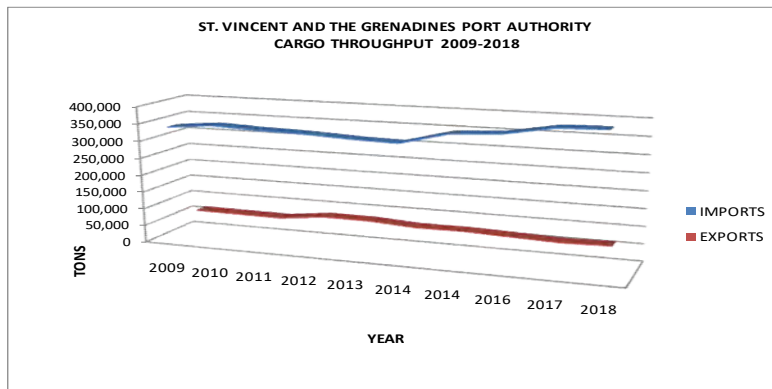

Total cargo flow for the year 2018 amounted to 460,745 tons; an increase of 1.7% or 7,607 tons when compared to the total tonnage recorded in 2017, which amounted to 453,138 tons. Imports for 2018 amounted to 399,655 ton while exports registered 61,090 tons.

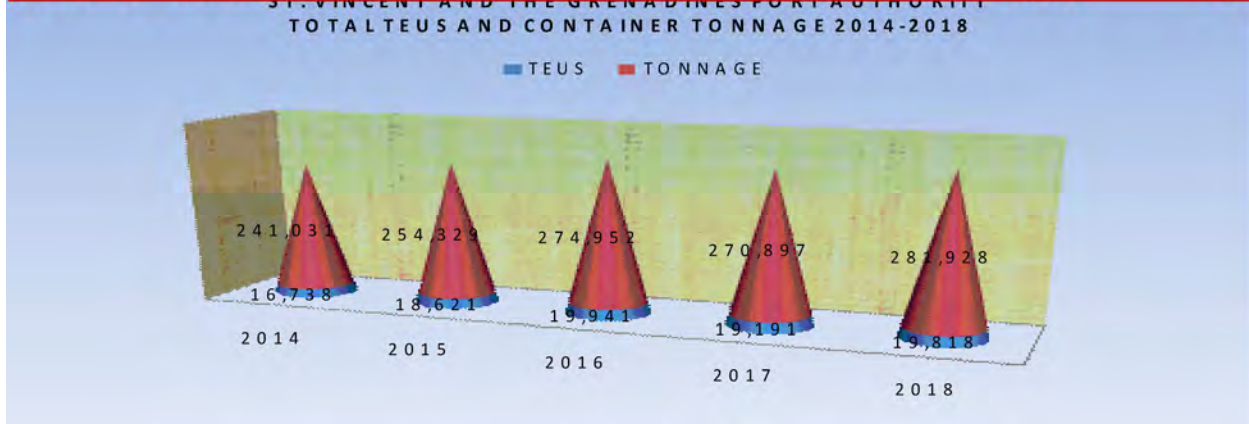

Total TEUs for 2018 amounted to 19,818; an increase of 3.27% or 627 TEUs over 2017, which recorded a count of 19,191.

Container Tonnage for 2018 amounted to 281,928 tons. An increase over 2017 of 4.07% or 11,031 tons. The total Container Tonnage reported for 2017 was 270,898 tons.

The positive growth experienced by both TEUs and Container tonnage can be the result of the increase in container boxes which climbed from 12,730 in 2017 to 12,965 in 2018. An increase of 235 boxes or 1.84%.

The 2017-2018 cruise ship season saw a total of 270 cruise calls with 239,081 passengers visiting our multi-island state. A total of 97 calls and 197,536 passengers landed at Port Kingstown; while 173 calls carrying 41,546 passenger landed at three ports of entry in the Grenadines. Seven cruise ships made their inaugural call during the season; six of which made calls at Port Kingstown. They were cruise ships Crystal Synphony, Aida Perla, Queen Victoria, Preziosa, Veendam and Seven Seas Navigator. The cruise ship Marella Explorer made her inaugural call at Port Bequia.

In comparison to the 2016-2017 cruise season there was a 23.9% increase in calls and a 97.3% increase in passengers. The huge gains made in passenger arrivals is mainly due to the increase in calls by high capacity ships such as Britannia and Fantasia at Port Kingstown.
